Benefits Applicable to All Membership Options Above:

- **Charging Privilege:** Cart fees, merchandise, food & beverage, and more.
- **Restaurant Minimum:** All memberships (except Junior) are required to purchase a minimum of \$50 in food or beverage each month at the Cedar Ridge Grill.
- **Discounts:** Members receive the following discounts: 10% food & beverages purchases, 15% clothing/accessories, and 10% on equipment purchases.
- **Optional Golf Cart Usage Fee -** \$70 per month or \$840 for the entire year (single). Couple rate is \$100 per month or \$1200 for the entire year (see cart plan agreement).
- **Optional-Unlimited Range Use** \$50.00/month individual or \$65.00/month couple
- **Complimentary USGA GHIN Handicap:** White Horse will record the golfer's handicap, but all Men's/Women's Club Fees are an independent additional cost.
- **Guest Pass:** Members will receive one quarterly guest pass per membership. Guest passes have the same restrictions as the annual member who is using it. Not valid on any holidays nor do guest passes carry over/accumulate if not used in each quarter.
- **Member Referral:** For each new member you refer receive one complimentary month of membership (limit of 3 referrals per membership per calendar year). Complimentary month will be applied to the next calendar month after referral.
